Manning Lighting is designed and manufactured by Manning Lighting, Inc. ("Manning"). This is Manning's exclusive written warranty. Manning warrants to the original buyer only each light fixture to be free from defects in materials and workmanship during normal usage for the Warranty Period listed above from the date of shipment to the original buyer. Upon any failure of a product to comply with this limited warranty, Manning's sole obligation, and buyer's sole and exclusive remedy is for Manning to promptly repair or replace (at Manning's option) the unit and return it to the original buyer, freight prepaid. This limited warranty is subject to the terms and conditions outlined below.

MANNING IS PROVIDING THIS LIMITED WARRANTY IN LIEU OF ALL OTHER WARRANTIES, WHETHER ORAL, WRITTEN, EXPRESS, IMPLIED, OR STATUTORY. MANNING DISCLAIMS AND EXCLUDES ALL OTHER EXPRESS AND IMPLIED WARRANTIES OF EVERY TYPE AND KIND, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. MANNING'S WARRANTY OBLIGATIONS AND BUYER'S REMEDIES HEREUNDER ARE SOLELY AND EXCLUSIVELY AS STATED HEREIN. MANNING DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES. Some states/provinces do not allow limitations on how long an implied warranty lasts, or the exclusion or limitation of special, incidental or consequential damages, so these limitations and exclusions may not apply to you. This warranty gives you specific legal rights. You may also have other rights, which vary from state/providence to state/providence.

TERMS AND CONDITIONS This limited warranty does not apply to products that have been abused, damaged, altered or misused by any person or entity after title passes from Manning. In addition, this limited warranty only applies when Manning products are: properly wired and installed, operated on a suitable power supply in accordance with the parameters specified in the applicable product Specification Sheet, used in environmental conditions (temperature, humidity) within the normal specified operating range of the Product. There are no run-time restrictions, 24 hour / day operation included.

This warranty does not apply to any components provided, but not manufactured by Manning, including ballasts, drivers, lamps and LED modules. Warranty claims on these items should be directed to their manufacturer. This warranty does not apply to any abnormal use or use in violation of any applicable standard, code or instructions for use in installations including those contained in the latest National Electrical Code (NEC), the Standards for Safety of Underwriters Laboratory, Inc. (UL), Standards for the American National Standards Institute (ANSI) or, in Canada, the Canadian Standards Association (CSA).

LED products must show failure of individual LED diodes greater than 10% of total number of diodes for a product to be considered defective.

RETURN OF DEFECTIVE PRODUCT Products returned for warranty claims must be received by Manning prior to the expiration of the Warranty Period. Except as specified below, the original buyer may not return products to us without our prior written approval and without first obtaining a return material authorization number, which we may withhold in our sole discretion. The return material authorization number must be displayed on the shipping container and the original buyer must complete and return a failure report with the shipment. Returned products will be promptly repaired or replaced, at our option, and returned freight pre-paid to the original buyer. The original buyer shall bear all of the risk, and all costs and expenses, associated with products that have been returned to us if there is no defect found or which are returned without a return material authorization number. The original buyer must provide us with shipping instructions to return replacement or repaired products. Proof of purchase (original sales invoice) must be provided to Manning with all warranty claims. Manning is not responsible for labor charges, removal charges, installation, or other consequential costs. In no event shall the liability of Manning exceed the purchase price of the product from which the claim arises.
